I think most of our Veterans would be well aware of the enormous changes which have occurred in the Australian telecommunications industry over the past fifteen years. Not only has OTC ceased to exist, but there are so many competing companies active in the industry today, that only a few people would be *aware* of them all, and virtually none of these specialises exclusively in international telecommunications. Employment is also no longer likely to provide any security of tenure. This being the case, it is almost impossible for anybody to aspire to achieve (say) fifteen years in that particular line of business, which is the OTVA minimum requirement for membership.

In such an environment it might be reasonable to suggest that an association like the OTVA, which is based exclusively on people who have worked in international telecommunications, is an anachronism and doomed to expire very soon.

It is therefore all the more remarkable that so many n-employees of OTC continue to attend the OTVA reunions and ACMs, and many more go to the trouble of organising social occasions and web pages for ex-OTC employees who are either inelligible to join the OTVA, or who find our reunions are scheduled at times which do not suit them.

These facts have troubled your Committee for some time. We feel that it is the obligation of the OTVA to provide an opportunity for our fellow ex-OTC employees to join with us socially and share the same spirit of camaraderie as we Vets have enjoyed for many years. For these reasons we have spent many hours considering the type of organisation we believe the OTVA should be today, and preparing a new Constitution which reflects those values.

This proposed new OTVA Constitution, which is contained in this issue, represents your Committee's views on the shape which our Association must assume in order to survive and prosper in the years ahead. Our existing Constitution is based upon a State Branch structure, which was quite appropriate in those days when all reunions and AGMs were fully funded by OTC and the costs associated with producing and distributing the OTVA Newsletter were also carded by the same employer organisation. However, this concept is no longer feasible in our present day environment where we must all contribute towards the costs if we wish to enjoy these benefits. This does not preclude OTVA members in each State organising their own reunions and other functions; far from it. It simply means that the production of the Newsletter and the activities we undertake to endeavour to save and protect the OTC archives are centralised, and we are able to take steps to make this organisation as accessible to other ex-OTC employees as possible.

The adoption of a new Constitution is not an insignificant step and we have pondered long and hard about the most democratic way to accomplish this, given the fact that many of our members are located too far away to be expected to attend the Special General Meeting to vote on this issue.

The process which we have decided to follow is therefore as follows: A Special General

Meeting of the OTVA, followed by a reunion, will be held at the CTA Club, Martin Place, Sydney, at noon on 15 March, 2002. Official notice of that meeting is contained in this issue of the Newsletter, together with an optional postal vote, which financial members may lodge if unable to attend the SGM.

At that meeting, members will vote upon the adoption of the new OTVA

Constitution. Discussion will be encouraged and any questions will be answered, but no amendments will be accepted from the floor, since postal voters would not have the opportunity to consider such proposals.

The proposed new Constitution will be either adopted or rejected by that meeting

Should a majority of the voters at the SGM vote for the adoption of the new Constitution, I shall write to each of the (two) surviving State OTVA Branches and request that they put this issue before their respective memberships and advise me of the outcomes. Members who have taken part in the postal vote option will be asked to abstain from voting in their State Branch polls on this issue.

Should a majority of voters in either of those State Branches vote in favour of the adoption of the flew Constitution, I shall ask attendees at the next Annual General Meeting to formally adopt that Constitution.

I ask you to give your complete support to this proposal. It represents the unanimous view of your Committee and it presents a unique opportunity for the OTVA to gather new strength and to provide the focal point for all international telecommunications veterans (and survivors) for years to come.

I commend the proposal to all OTVA members.
